Introduction:

Wellness Fiji is an approach 'to living that emphasises the whole person' (taken from Wellness Fiji Facebook page). Wellness encompasses several dimensions of how to be healthy-everything from physically to spiritually and financially. By prioritising wellness and healthier lifestyles, the people of Fiji can embrace a holistic view of wellbeing, and work on each dimension of caring for themselves and their community. The Wellness Fiji approach has been instated by MoHMS to form the foundations of a re-evaluated first primary healthcare delivery, so that each sphere of an individuals needs (through work, play and life) is targeted, as well as expanding partnerships to local health workers and communities. Many NGO's are keen to advance this approach by targeting these dimensions through community work and providing vital services in line with the NSP targets. Cultural Heritage Funding:

Cultural heritage funding can be limited, due to international funding prioritising physical health and education, but Wellness Fiji recognises the importance of highlighting and maintaining an education and appreciation of Fiji's heritage. Local funding initiatives are more likely to provide funding for these areas, however this may not be enough to cover all costs. NGO's in this particular area may need to access other cross-cutting themes in order to cover multiple requirements and access different funding opportunities not necessarily aimed towards sustaining cultural activities. For example, if your project involves particular groups (such as educating children or providing community for people with disabilities), accessing different areas (such as rural communities) or offers a service, your NGO may be more eligible for funding internationally. This should be kept in mind when marketing your projects, as to ensure you are covering a large range of opportunities and are more successful.

Questions you could ask to help decide on a different angle for funding are:

Who are you reaching?

Does it educate people on topics regarded as important in the UN Sustainability goals?

Who runs the project?

Is is able to be marketed as a business?

Glossary:

EO1 Form-Abbreviation of Expression of Interest form, which indicates an organisations interest in a particular grant or product a company is selling/offering. These forms can be given by the company selling the product or can be produced by the organisation. It is sometimes also called a Letter of Inquiry.

Funding Proposal-Can vary in length depending on how much detail is needed to be presented. It is a document used to request funding for a particular project or organisation, usually containing the goals of the project, an overall budget for the project and a set of measures that will evaluate the success of the project.

Unsolicited Proposals-An unsolicited proposal is a proposal a company has not requested to receive, but has been proposed either because of an urgent need for funds or an organisation believes they are particularly in line with their aims and criteria.

Solicited Proposals-A solicited proposal is a proposal that has been sent in response to a request for proposals.

Pro-bono-Professional work completed freely and without payment, and is usually related to legal services and advise.

Case for support - A document used to support a proposal to for philanthropic gifts. A case for support details what you intend as an organisation to accomplish with the money given by the donor. This usually details a particular project or campaign that will come as a result of the philanthropic investment.

IPV-Abbreviation for Intimate Partner Violence
